9 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN  
10 AS FOLLOWS:

11 SECTION 1: Title 19, Chapter 00, Section 60, Subsection (D), of the Municipal Code  
12 of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

13 (D) Computation of Time. The time within which an act is to be performed shall be computed by  
14 excluding the first day and including the last day. If the last day is a Saturday, Sunday, [or] legal  
15 holiday, or other day on which the City's principal administrative offices are officially closed to the  
16 public, that day shall be excluded. The following time-related words shall have the meanings ascribed  
17 below:

18 "Day" means a calendar day unless otherwise stated.

19 "Week" means seven calendar days.

20 "Month" means one calendar month.

21 "Year" means a calendar year, unless a fiscal year is indicated.

22 SECTION 2: For purposes of Section 2.100(3) of the City Charter, LVMC 19.00.060  
23 is deemed to be a subchapter rather than a section.

24 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or  
25 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or  
26 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or  
27 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the  
28 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,

1 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,  
2 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,  
3 invalid or ineffective.


4 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,  
5 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,  
6 1983 Edition, in conflict herewith are hereby repealed.

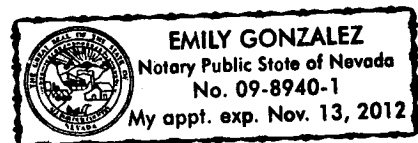
