**AUTHORITY:** Charter 4.020.4 and LVMC 2.26.040.

**APPOINTMENT:** The Mayor appoints a sufficient number of Alternate Judges yearly.

**COMPENSATION:** \$100 for each morning, afternoon, or evening session of the Court at which they preside.

**REQUIREMENTS:** Must be a duly licensed member, in good Standing, of the Nevada State Bar and shall possess the same qualifications required of the elected Municipal Court Judges, EXCEPT that Alternate Judges DO NOT forfeit office if they cease to be a resident of the City.

**NOTE:** City residency requirement - No financial disclosure requirement.
